CONDITIONS GOVERNING APPROVAL TO CLUBS

The host club has agreed:

1. To accept the decisions of Tennis East Gippsland.
2. In the event the club runs the tournament and supplies the used balls – pay Tennis East Gippsland the amount of \$2 per player.
3. In the event Tennis East Gippsland runs the tournament – pay Tennis East Gippsland \$5 per player.
4. To allow the display of the Tennis East Gippsland logo and sponsors' display in a prominent position during the tournament(s).

CONDITIONS GOVERNING CONDUCT OF TOURNAMENT(S) & PLAYER(S)

1. Tournament(s) shall be conducted in accordance with Tennis Victoria Regulations.
2. The code of conduct as approved by Tennis Australia will be enforced during tournament(s).
3. Tournament(s) shall be under the sole control of the Tennis East Gippsland which shall have the power to reject any entry without stating the reason.
4. Events shall be conducted as prescribed feed-in events.
5. Tennis East Gippsland shall prepare the draws.
5. The approved feed-in Tournament Draw form shall be used.
6. **Entrant numbers may be limited dependent upon available courts.**
7. Where entrant numbers are limited, players with better entry records shall have precedence.
8. Good quality used balls shall be used.
9. The length of matches shall be, with 10/U being 6 game sets with tiebreaker at 5-all, and 12/U and 14/U and 16/U being 8 game sets with tiebreaker at 7-all.
10. The player entry fee into a tournament is \$7.
11. The club will provide a thermometer and no play is allowed whilst the temperature in a suitable shady position at the host club is 35° or more.
11. Players shall be the age or under at 30th April 2008.
12. Points will be allotted to each match of a tournament, with each player commencing a year with no points.
13. The top eight (8) points scorers in the Circuit tournaments will qualify to compete in the Masters Finals Tournament.
14. Where a top eight qualifier is unable to take his or her place in the Masters Tournament, the next highest points qualifier will be invited.
15. In the event of a tie between players in the number of points earned to take up the eighth position, each of the tied players will be invited to take a place in the Masters Tournament.
16. **Entry and results in Circuit tournaments is a factor taken into account in selecting juniors seeking a position in a TEG representative team.**
