- Closer relationship with Central Gippsland
Discussion followed the suggestion at the recent Country Conference at Grace Park in relation to forming a closer working relationship with Central Gippsland. Issues raised included administrative and competitive opportunities. Glenn Schuback will liaise with representatives of Central Gippsland and report periodically.
- Junior Masters
It was resolved to continue to conduct the Lead-in events at Sale in October, Bairnsdale in November, Maffra in December, and Lakes Entrance in February, followed by the Masters in Bairnsdale in March/April with specific dates to be advised after liaison with associations and clubs.
- Junior Cups
Representative teams' results were reported in the President's Report and it was resolved to ensure positions in these teams continue to be sought after by our juniors. It was noted that a

team (boys and girls 10/U, 12/U, 14/U and 16/U) could not be filled for the June Associations and Regional Challenge in Bendigo with some players preferring to contest tournaments at that time.

Proposed Second Optus Junior Tour Tournament

It was reported that Sale are seeking to bring a second tournament to East Gippsland to complement the event which has been conducted at Bairnsdale since 2005, providing local juniors another opportunity to test themselves against metropolitan and country peers. The program and dates of this tournament have not been finalised as yet.
